
The Secretary & Correspondent, **STEM School, 1<sup>st</sup> Lane, 1<sup>st</sup> Cross, Vidyanagar, Guntur** under the management of **The Diocese of Guntur Society, Bishop House, Chandramouli Nagar, Guntur** has applied for according Provisional Recognition with classes Nursery to VII (EM) during the academic year 2016-17 to 2025-26..

The Mandal Educational Officer, Guntur has inspected and submitted his report in the reference 4<sup>th</sup> cited.

After careful examination of the proposals from the society and also the inspection report of the inspecting officer in the reference 4<sup>th</sup> cited permission is here by accorded for Provisional Recognition to **STEM School, 1<sup>st</sup> Lane, 1<sup>st</sup> Cross, Vidyanagar, Guntur** with classes Nursery to VII(EM) during academic year 2016-17 to 2025-26 without any aid now or in future subject to the following conditions:

1. That the society shall abide by the rules and regulations made in the Government orders in 1<sup>st</sup> to 2<sup>nd</sup> read above cited above and also issued from time to time.
2. That the Educational Institution shall needs of the locality more particularly.
3. That the Institution shall adopt curriculum and syllabus prescribed from time to time by the Govt., of AP.
4. That the school timings, vacations and mid terms holidays shall be prescribed by the government from time to time.
5. That the qualified staff with in the age limits prescribed by the Government for Government employees shall be appointed as per the staff pattern.
6. That the results of the institution shall be satisfactory of every year.
7. That the records / accounts, annual administrative report along with the audited accounts should be submitted to the District Educational Officer, every year.
8. That the list of Governing Body shall be furnished to the D.E.O., every year.
9. That the pay structure / fee structure fixed by the Governing body shall be submitted to the District Educational officer every year.
10. That all the conditions prescribed in the G.Os and other orders which are not specified in this orders shall be complied with.
11. That the school shall not be closed without giving notice both to the parents District Educational Officer and the competent authority at least 6 months before.
12. That the school shall be closed (or) permitted to be closed only from the date on which summer vacation is declared.
13. That the society shall submit proposals for renewal of Provisional Recognition sufficiently in advance i.e., at least 6 months prior to the date of expiry of recognition.
14. The school managements shall submit an affidavit every year with regard to non- violation of rules / regulations prescribed by the Government from time to time.
15. The management shall obtain renewal of NOC from the District Fire Officer, Guntur every year and produce for verification as and when requested.
16. The Management shall obtain renewal of NOC for Structural Soundness Certificate from Executive Engineer concerned every year without fail and produce for verification as and when requested.
17. Fitness Certificate for all school buses shall be obtained from the competent authority every year.
